Cookies

Cookies are text files stored in your browser. This site uses Cookie Consent to help comply with the latest EU ePrivacy laws.

The Guildhall School eGo and Online Applications systems use

- First party session cookies for security
- Cookies from Google Analytics, a web analysis service of Google Inc.
- Tracking cookies from advertising campaigns

Security cookies

There is an exception in the law for cookies which are deemed as "strictly necessary". The term "strictly necessary" means that such storage of or access to information should be essential, rather than reasonably necessary, and this includes cookies used for security requirements.

Log files

User access data is collected on these systems for system administration, identifying errors and for producing usage statistics. Logged information includes data such as login status, IP address and device information such as browser, operating system and device type.

Google Analytics

Google Analytics uses only first-party cookies. This means that all cookies set by Google Analytics for the Guildhall School send data only to the School's servers. This data cannot be altered or retrieved by any service on another domain and we will never disclose information stored in your cookie to third parties.

The Google Analytics Terms of Service, which all Analytics customers adhere to, prohibits the tracking or collection of personal information (such as name and email address) using Google Analytics or associating personal information with web analytics information.

Cookies collect information about your computer, including your IP address, operating system and browser type, for statistical, non-identifiable purposes. They allow us to estimate information such as audience size and usage patterns, for example whether the visitor has been to the site before, which country they are in and what site referred the visitor to the web page.

Advertising campaigns

Cookies may be set on other websites for example to learn whether someone who was served an advert on Facebook later visited our application site.

Can I opt-out of cookies?

Yes. You can adjust your internet browser settings to not accept some or all cookies, or choose to allow only certain 'trusted' sites to store cookies on your computer. Google Analytics also provides an opt-out browser add-on which you can download at

We do not share personal and financial information provided to us in the payment process, nor do we share this information with 3rd parties.

We use Paypal to take secure online payments. The data sent between the School and Paypal includes identification information, payment requirements and details of whether the transaction was successful. No financial information (debit/credit card details or bank details from your Paypal account) is shared with the Guildhall School.
